

## Rules for accommodation

Please follow these rules:

Please give us your personal information upon your arrival at the latest. We need to write them into the book of visitors.

You will pay a refundable deposit of CZK 3000,-/suite (max. 12000,-/house). It will cover eventual damages on the property. When the house and it's garden are returned in order and without damage, the deposit is to be returned in full at the last day of your stay. All damages are to be reported at once, so that we can repair/replace them.

Please be respectful to other visitors accommodated in the house.

Please keep the house and it's surrounding in order. Also separate your waste (plastic, paper and glass). Dustbins are located in front of the house across the street. There are two dustbins for the ordinary waste along the street before the house as well.

There is a strict ban for smoking inside of the house. Ashtrays are located in the open air kitchen.

There are designated fire places in the garden. Fire at any other place is strictly forbidden. At the end I is necessary to extinguish the fire by water. The same applies for the fire place at the pond.

Wood is available at a price of CZK 1200,-/1m<sup>3</sup>. It is forbidden to take any other wood located around the house.

At the entry space of the Velky apartment the fire extinguisher is located. There is also one in the open air kitchen at the place of a historical toilet.

Please do not move any stuff from one room to another. That includes the kitchen itinerary.

Please use everything according to its original purpose. All toys and accessories for kids are limited up to 20kg of their weight.

Before using any equipment you are responsible to check its technical condition and feasibility for use. If there are any visible damages, you should avoid using it. In such a case we are sorry for such situation and will repair or replace it as soon as possible.

It is possible to take a bath in the river and the average depth in front of the house is 30-50 cm. At the pond close to the dam it is cca 3,5 meters. Please do not allow any children to enter the water without the supervision of an adult.

Be aware of the limited height of certain doors. In the past people were of a lesser stature.

It is forbidden to use your own electro devices, except for shaving and massage devices.

The owner of the house is not responsible for damage or loss of things brought in by the guests.

Entry, movement in the house and the garden and subsequent responsibility for it is upon the guest.

Parking is allowed only at the house along the entry way towards the river. Please do not block that access road. It is strictly forbidden to park at the place between the house and the river.

It is possible to have an animal with you under the following rules. Your pet cannot bother other people in the village. The pet cannot be inside of the building without its owner, and cannot sleep in any bed. Please have your animals under your control and do not let them to pollute the house surroundings.

Under normal circumstances you can be visited by your friends for couple of hours. But it is forbidden to stay longer in or outside of the house. The reason is higher costs of the facility.

Please report immediately any damages or malfunctioning of any accessories. Do not try to repair it on your own.

Generally please act in the way that other customers could fully use the house and its accessories.

When another group is arriving at the day of your departure, the house needs to be ready handed over at 9 a.m. If that is not the case, the departure time can be agreed upon with the owner.

Some other information:

Wifi is accessible without a password.

Each guest is obliged to follow above rules. In case of a trespassing these the owner is allowed to terminate the accommodation accordingly.

Below are situations which are such cases for the termination:

- Repeated violation of above Rules.
- Wasting of the water or electricity without a reason.
- Mean behaviour of the guest towards its neighbours or the owner.
- Additional persons staying in the object without approval of the owner.
- Disturbance of the neighbours during evening/night.
- Attack of any animals in the ownership of the guest towards its surrounding.
- Inconvenient handling of music instruments and accessories.
- Intentional damage of the object and its accessories.
